## FREEDOM OF INFORMATION (FOI) PEOPLE'S MANUAL

### WHAT IS FREEDOM OF INFORMATION (FOI)?

Freedom of Information (FOI) is the right of every Filipino citizen to request and receive information from government offices. This right is guaranteed under **Executive Order No. 2, s. 2016**, subject to certain limitations provided by law.

The City of San Fernando Water District (CSFWD) supports transparency and accountability by making government information accessible to the public.

### WHO CAN REQUEST INFORMATION?

Any **Filipino citizen** may file a request for information with CSFWD.

### WHAT INFORMATION CAN BE REQUESTED?

You may request information related to:

- CSFWD programs, projects, and activities
- Policies, plans, and official issuances
- Reports, records, and other official documents

*Some information may not be disclosed if it falls under FOI exceptions such as national security, personal privacy, or matters protected by law.*

### HOW TO REQUEST INFORMATION

You may submit your FOI request through any of the following:

• **In person:** Visit the CSFWD Office during official working hours

Please provide a clear description of the information you are requesting and your complete contact details.

### HOW LONG WILL IT TAKE?

- CSFWD will acknowledge your request within **15 working days**
- Processing may be extended for up to **20 additional working days** if necessary
- You will be informed of the status of your request

### ARE THERE FEES?

Filing an FOI request is **free of charge**. However, reasonable fees may apply for photocopying, printing, or certification of documents.

### WHAT IF MY REQUEST IS DENIED?

If your request is denied, you may file an **administrative appeal** within **15 calendar days** from receipt of the notice of denial.


